



## **Gwida ġenerali għal-liċenzja tal-falkunerija**

### **Awtoritajiet Responsabbli**

It-Taqsimat tar-Regolamentazzjoni għall-Ghasafar Selvaġġi hija responsabbli għar-regolamentazzjoni u l-liċenzjar tal-attività tal-falkunerija. Dawn il-liċenzji huma regolati bir-Regolamenti tal-2016 dwar il-Konservazzjoni tal-Ghasafar Selvaġġi (Falkunerija) (S.L. 549.106).

### **Proċedura tal-applikazzjoni għal-liċenzja tal-falkunerija**

#### Dawn huma l-proċeduri applikabbli:

1. Persuna għandu jkollha mhux inqas minn sittax-il sena.
2. Persuna trid tkun membru ta' organizzazzjoni tal-falkunerija rikonoxxuta.
3. L-applikant għandu jkun kopert b'polza ta' assigurazzjoni għal riskji ta' terzi persuni li tkopri l-attività tal-falkunerija.
4. L-applikant għandu jiehu kopja tal- *insurance* u l- *ID card* u ċertifikati ta' *CITES* flimkien mal-applikazzjoni ittimbrata u iffirmata mil-organizzazzjoni tal-falkunerija l-uffiċju tat-Taqsimat tar-Regolamentazzjoni għall-Ghasafar Selvaġġi u jhallas l-miżata dovuta għal-eżami (€30).
5. Fil-kas ta' speċi li m'humiex obligati ikollhom ċertifikat ta' *CITES* huwa mitlub li l-applikant jippreżenta in-numru taċ-ċurkett tal-ġenituri ta' li speċi u l-*invoice* ta' min fejn inxtara l-ghasfur.
6. L-applikant jiġi nnotifikat mill-għaqda tal-falkunerija rispettiva dwar il-ġurnata, l-ħin u l-post ta' fejn ikun ser isir l-eżami Prattiku.

7. L-eżami prattiku issir mill-ghaqdiet tal-falkunerija taht is-supervizzjoni tat-Taqsima tar-Regolamentazzjoni għall-Ghasafar Selvaġġi.
8. La darba l-applikant ikun għadda mil-eżami prattiku, jirċievi ittra bil-gurnata, l-hin u l-post ta' fejn ikun ser isir l-eżami bil-miktub dwar ir-Regolamenti tal-2016 dwar il-Konservazzjoni tal-Ghasafar Selvaġġi (Falkunerija) (S.L. 549.106) u l-identifikazzjoni tal-ghasafar.
9. L-applikant jiġi nnotifikat bir-rizultat fi zmien għaxart ijiem wara li jkun għamel l-eżami.
10. Hekk kif falkunier jgħaddi mil-eżami bil-miktub għandu jhallas il-mizata abbinata mal-liċenzja (€50), it-Taqsima tar-Regolamentazzjoni għall-Ghasafar Selvaġġi toħroġ il-liċenzja tal-falkunerija valida għal hames snin.
11. Hija r-responsabbiltà tal-falkunier liċenzjat li jassigura li jgħedded is-shubija annwali ma' ghaqda tal-falkunerija u l-*insurance*.
12. It-Taqsima tar-Regolamentazzjoni għall-Ghasafar Selvaġġi tista' toħroġ liċenza speċjali għall-attività tal-falkunerija, li tista' tkun mahruġa biss għall-perjodu definit u flimkien ma' attività speċjali.



## **Guidance note for the acquisition of falconry licence**

### **Responsible authorities**

The **Wild Birds Regulation Unit** is responsible for regulating and issuing of falconry licences. These licences are regulated by the Conservation of Wild Birds Regulations (Falconry) (Subsidiary Legislation 549.106).

### **Procedure for applying for a falconry licence**

The following procedure applies:

1. A person must be at least sixteen years.
2. A person must be a member of a recognized falconry association.
3. The applicant should be covered with a third party liability insurance covering the activity of falconry.
4. The applicant should present insurance, ID card and CITES certificate together with the filled application form, which should be duly signed and stamped by the falconry organisation, and pay the € 30 examination fee to the Wild Birds Regulation Unit.
5. For species that do not require CITES certificate, the falconer should present the closed ring number of the specimen's parents and the invoice from where he/she bought the bird.
6. The applicant will be informed by his respective falconry organisation of the date, time and place where the practical exam will be held.
7. Practical exam on the maintenance, flight and protection of the falcon will be administered by the falconry organisations supervised by the Wild Birds Regulation Unit.

8. Once the applicant passes the practical exam, he/she will receive a letter with the date, time and place where the written exam concerning the Conservation of Wild Birds Regulation (Falconry) (S.L.549.106) and bird identification will be held.
9. The applicant will be notified with the result within ten days following the successful completion of the examination.
10. When one passes the written exam, he/she should pay the €50 fee to the Wild Birds Regulation Unit so that a falconry licence valid for 5 years is issued.
11. It is up to the falconer to renew annually his organisation membership as well as the insurance.
12. In addition to the general falconry licence, the Wild Birds Regulation Unit may also issue a special falconry activity licence, which may only be issued for a definite period and in conjunction with a special activity.
